TERMS & CONDITIONS

All Hospitality Packages are issued subject to these Conditions of Sale and Entry 2009.

Bookings can only be accepted on receipt of a completed and signed booking form.

The completed, signed Super X Hospitality booking form and these terms and conditions form a legally binding contract between the company or persons named on the form and Super X Australasia Pty Ltd. This agreement sets out the terms on which the client will acquire and Super X Australasia Pty Ltd will supply hospitality.

Accreditation

Super X Hospitality guests will receive one individual hard card and lanyard per round per guest. These hard cards provide access to the Super X Paddock area, and the specific Hospitality area.

Cancellation

Should the client wish to cancel their booking, they must do so in writing. If the booking is cancelled by Super X Australasia Pty Ltd, 100% of the booking payment will be refunded. Cancellations by the client will be accepted with no fee up to 30 days

prior to the event. Cancellations within 29 days will attract a 50% cancellation fee and cancellations 5 days prior to the event will lose the total amount.

Code of Conduct

All guests are requested to comply with the following:

- Tickets/Passes must be worn correctly at all times (tickets/passes to be worn around the neck with hospitality package facing out).
- Tickets can only be used by one person.
- Children under 18 years of age are to be accompanied by an adult in all bars and dining rooms.
- Children under the age of 5 are not permitted in the Lounge Club or Sponsor areas.
- Clients/guests should refrain from using foul language.
- Uninvited guests will not be permitted. NO TICKET, NO ENTRY, NO EXCEPTIONS.
- Super X Australasia Pty Ltd practices the responsible service of alcohol.

Please note:

- The Hospitality Manager has the discretion to remove anyone displaying unacceptable conduct from the relevant areas. Stadium security also has the discretion to remove anyone displaying unacceptable conduct.

Distribution of Ticketing

Tickets will be forwarded to you within 10 working days prior to the event. Tickets will not be sent until full payment has been received.

Dress Code

Super X Australasia Pty Ltd encourages smart casual attire for all guests. Eg. Collared shirt and tailored pants or shorts for males. This means no singlets, no thongs and no board shorts.

Hospitality

In this agreement the hospitality supplied by Super X Australasia Pty Ltd to the client includes all details outlined in the event packages within this hospitality brochure.

Indemnity and Liability

Super X Australasia Pty Ltd will not be liable for any loss or damage to any item of property brought into a Hospitality area by a guest. Guests should make sure that they keep all valuable items in their possession at all times, which includes such things as wallets, watches and mobile telephones. Super X Australasia Pty Ltd will not accept responsibility for the loss of, or damage to, any of these items.

Payment
